

## Safe Jobs for Youth Month Video Contest Official Guidelines and Contest Rules

We are looking for youth to create fun videos that cover THE BASICS: **6 Things Young Workers Need to Know** to Keep Safe at Work. We need your youth voice to help us share this important information! We want original content so be creative! Your video can be animated, documentary-style, acted out, sung--whatever you think will be compelling for other teens and young workers.

### Guidelines and Eligibility:

- Filmmaker must be 14-18 years of age and living in California.
- All entries must be received by **Wednesday February 28, 2018**.
- All content, including music must be originally created
- This video should be short--no more than 3 minutes long.
- All participants (producers, musicians, actors, etc.) must complete Permission Form.
- **Your video must address the information from ONE of the 6 videos:**
  - Video 1: Every Job Has Hazards
  - Video 2: Hazards Can be Addressed
  - Video 3: Laws Protect All Workers on the Job
  - Video 4: Special Laws Protect Teen Workers
  - Video 5: What If You are Injured
  - Video 6: How to Problem-solve and Get Help

### Winners:

A complete list of winners and honorable mentions will be announced first on social media and winners will then be notified individually no later than **May 1, 2018**. Honorable mentions will not be contacted individually.

- **1st Prize:** \$300 to participating filmmaker. In addition, the first prize-winner's school or organization will receive prize of \$100.
- **2nd Prize:** \$200 to participating filmmaker
- **3rd Prize:** \$100 to participating filmmaker
- **Honorable Mentions:** Video clip will be announced and posted on social media.

## To Submit Your Entry:

### ***Remember all entries are due on Wednesday, February 28, 2018***

1. Upload your video to YouTube. Be sure the privacy settings for the video are public or unlisted (but not private.)
  - You will need to follow the Community Guidelines and make sure you are wholly compliant and consistent with the YouTube Terms of Service. Any entries that don't comply will be disqualified.
  - *Please note: YouTube is NOT a sponsor of this contest*

## Permission Forms:

All participants, including producers, actors, musicians, and anyone else whose image or sound is on your submission, must turn in a signed entry form along with the video. Your permission allows us to promote the contest and spread the word on youth safety through the use of your message. Please have everyone who appears on the screen fill out the appropriate form. ***These forms must be completed for you to receive your prize money should you be one of our contest winners.*** The School/Teacher/etc. information on the entry form is requested – if applicable – so that we can give credit when teachers assign, encourage, and/or enable participation in the contest. If you are producing your video on your own, please disregard that part of the form.

### Conditions:

All footage, including music, must be originally created material or you must obtain proper legal permission to use someone else's copyrighted material. Entries will be void if they are incomplete, late lost, damaged, or are not able to be viewed due to technical error. No entries will be returned. All entrants give the Young Workers Project at the Labor Occupational Health Program, University of California at Berkeley permission to use the videos, including the right to use their names, photographs, and video submissions for advertising, publicity and promotion purposes, and to edit or make changes to the announcement. By entering this contest, entrants agree to abide by these contest rules and regulations.

### Who Sponsors the Contest:

The Safe Jobs for Youth Month Video Contest is conducted by the California Partnership for Young Worker Health and Safety, a statewide collaboration sponsored by the California Commission on Health and Safety and Workers' Compensation and coordinated by the Labor Occupational Health Program at the University of California, Berkeley.
