Video Contest Official Guidelines and Contest Rules

This year we are looking for youth to create fun videos that cover THE BASICS: **6 Things Young Workers Need to Know** to Keep Safe at Work. We need your youth voice, to help us share his important information!

Guidelines

- Go check out the existing 6 videos (slide show/voiceover version) on our website here: www.youngworkers.org/safe-jobs-month/video-contest/
 - Video 1: Every Job Has Hazards
 - Video 2: Hazards Can Be Addressed
 - Video 3: Laws Protect All Workers on the Job
 - Video 4: Special Laws Protect Teen Workers
 - Video 5: What If You Are Injured
 - Video 6: How to Problem-solve and Get Help
- Decide which video you want to develop. **You can only choose one!**
- Review other information on the www.youngworkers.org website, to make sure you understand your rights on the job and how to stay safe.
- Think about how you can share this information with other teens in a way that will capture their attention. As long as you cover the basic content, you do not have to do it in the same order that we have, or with the same words. Your video can be animated, documentary-style, acted out – whatever you think will be compelling for other teens and young workers - check out past video PSA winners for style ideas at www.youngworkers.org/videos/
- The video should be short – no more than 3 minutes long.

Create a video using info from
ONLY 1 of the 6 videos

Eligibility

To be eligible, **your video must address the information in one of the 6 videos**, and must not run for more than 3 minutes. All entries must be received by 5pm, Monday January 9th, 2017. Each entry will require a separate entry form and should be submitted with a separate email. The video contest is open to youth between the ages of 14-18 who live in California.

Permissions

All participants, including producers, actors, musicians, and anyone else whose image or sound is on your submission, must turn in a signed entry form along with the video. Your permission allows us to promote the contest and spread the word on youth safety through the use of your message. Please have everyone who appears on the screen fill out the appropriate form. **These forms must be completed for you to receive your prize money should you be one of our contest winners.** The School/Teacher/etc. information on the entry form is requested – if applicable – so that we can give credit when teachers assign, encourage, and/or enable participation in the contest. If you are producing your video on your own, please disregard that part of the entry form.

Prizes

1st Prize: \$300 to participating filmmaker. In addition the first prizewinner's school or organization will receive a prize of \$100.

2nd Prize: \$200 to participating filmmaker.

3rd Prize: \$100 to participating filmmaker.

Winners List

All winners will be notified no later than May 1, 2016. A complete list of winners along with a video clip of the winning submissions will be posted on the Safe Jobs for Youth website: www.youngworker.org and distributed to partner organizations.

Conditions

All footage, including music, must be originally created material or you must obtain proper legal permission to use someone else's copyrighted material. Entries will be void if they are incomplete, late lost, damaged, or are not able to be viewed due to technical error. No entries will be returned. All entrants give the Young Workers Project at the Labor Occupational Health Program, University of California at Berkeley permission to use the videos, including the right to use their names, photographs, and video submissions for advertising, publicity and promotion purposes, and to edit or make changes to the announcement. By entering this contest, entrants agree to abide by these contest rules and regulations.

To Submit Your Entry

- Upload your video to YouTube. Be sure the privacy settings for the video are public or unlisted (but not private).
 - You will need to follow the [Community Guidelines](#) and make sure you are wholly compliant and consistent with the YouTube [Terms of Service](#). Any entries that don't comply will be disqualified.
 - *Please note: YouTube is NOT a sponsor of this contest.*
